
#### **Description**

The operating wavelength is 950 nm. The detector consists of a phototransistor.






Figure 1. Test circuit




Figure 2. Total Power Dissipation vs.
Ambient Temperature




Figure 3. Forward Current vs. Forward Voltage




Figure 4. Relative Current Transfer Ratio vs.
Ambient Temperature




Figure 5. Collector Current vs. Collector Emitter Voltage




Figure 6. Current Transfer Ratio vs. Forward Current




Figure 7. Collector Current vs. Distance





Figure 8. Relative Collector Current vs. Displacement


#### **Dimensions of TCRT1000 in mm**
